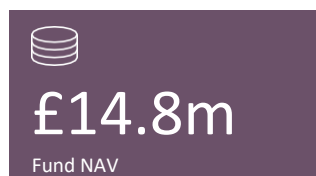
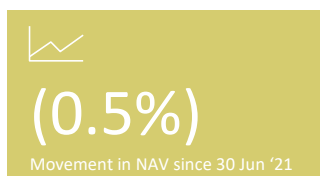
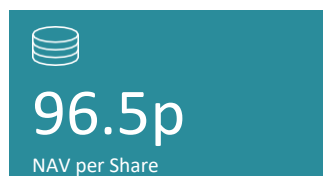

PORTFOLIO ACTIVITY

Since 1 July 2021, three new investments totalling £1.7m have been made into the Foresight Williams Technology VCT. Existing investee companies such as Audioscenic, AMT, Refeyn, Cambridge GaN and Insphere have made significant progress during the period.

Forefront RF

Forefront RF is developing signal cancellation technology to reduce the size and number of components used to receive cellular signals in mobile phones. Forefront RF's patent-protected technology would allow for a universal and 10x smaller filter module, enabling a simplified supply chain and more space within the handset, unlocking additional functionality and design flexibility.

A Loughborough University spin-out, Previsico's system, FloodMap Live, combines data with proprietary algorithms to produce automated flood alerts, highlighting areas close to flooding and provides a street level visualisation tool.

Zero Point Motion

ZPM is an early-stage semiconductor company which is developing a chip-scale Inertial Measurement Unit ('IMU') for ultra-precise motion-tracking and indoor navigation. Initially developed to detect collisions for airbag deployment, IMUs enable electronic devices to monitor their relative position, motion and acceleration. Once fully developed, ZPM's patented design, which combines the low-cost benefits of Micro Electromechanical Systems devices with the high level of accuracy achieved using Photonics, should bring the cost of a high performance IMU down to a price point suitable for mass commercial applications.



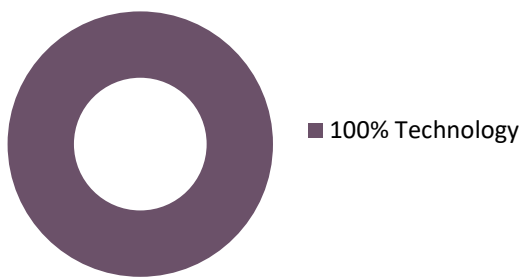
